RENTAL WARNING AND LIABILITY RELEASE* READ CAREFULLY BEFORE SIGNING

1. I accept for use AS IS the equipment listed on this form without warranties, express or otherwise, and accept responsibility for the care of the equipment while in my possession.
2. I WILL be responsible for the replacement of equipment rented under this form, but not returned to the shop. \$275-ski equipment, \$425 snowboards and \$30 per clothing item.
3. I agree to return all rental equipment by the agreed date in clean condition to avoid additional charges.
4. I understand that skiing is a HAZARDOUS sport which presents risk of injury or death and I freely and voluntarily assume those risks
5. I understand that the ski-binding-in-boot system will not release at all times or under all circumstances where release may prevent injury, nor is it possible to predict every situation in which it will release and it is, therefore, no guarantee of my safety. I further understand that, although the ski-binding-boot system may reduce the risk of certain injuries to the skiers lower leg, it likely CANNOT protect the knee or any other part of the skiers body.
6. I have received instructions in the use of this equipment and have received satisfactory answers to any questions I may have regarding the use and function of this equipment. If I feel the equipment is not functioning properly I will stop using it and have it inspected, repaired or readjusted by a ski binding technician.
7. To the fullest extent allowed by law, I hereby RELEASE, indemnify and hold harmless the ski shop and all manufacturers and distributors of this equipment, and to their owners, agents, and employees, from any and all liability for damage, injury or death to myself or to any other person or property which may result while using this equipment, and that I waive any right to present any legal claim or suit against these persons, whether based upon negligence, breach of warranty, strict product liability or any other legal theories.
8. I understand that there are inherent and other risks of injury in the sport of snowboarding for which this equipment will be used. These risks include but are not limited to variations in snow, steepness, terrain, trail side drop offs, ice, icy conditions, moguls, rocks, trees and other forms of forest growth or debris (on or under the surface), bare spots, lift terminals, cables, utility lines, snowmaking and snow grooming may be in progress at anytime.
9. I authorize Action Ski or its authorized personnel to call for medical care for me or my child by the area ski patrol at the destination resort. If in the opinion of such personnel medical attention is needed for me, I agree that upon my transport to any such facility or hospital that Action Ski shall not have any further responsibility for me. Further I agree to pay the costs of such medical care and related transportation cost provided for me and shall be binding to the fullest extent of the law and shall be binding upon assignees, heirs, next of kin, executors, personal representatives and administrators and may be pled by the shop as a complete bar and defense against any claim, demand, action or cause of action by or on behalf of the renter I HAVE READ, UNDERSTOOD AND AGREE TO THE TERMS OF THIS WARNING AND LIABILITY RELEASE AGREEMENT.
